City has no control over solar projects

Property owners adjacent to four proposed solar projects on Wilmington's doorstep found out last week there is nothing they, nor the city, can do to prevent them from coming.

Approximately 40 residents attended

a town meeting at City Hall where city officials detailed the projects and explained how Illinois law currently prevents towns and counties from restricting them.

'None of these solar projects are within the city limits and we can't force them to annex," Mayor Ben Dietz com-

mented. "The project owners would have to want to annex but that isn't going to happen. Why would they want to pay more taxes when they have no need for city services? We really have no control over them.

Will County has already approved two of the four projects. In October 2018, Fleishman Solar, LLC along Route 53 north of Coal City Road presented a 45acre project by Emeren Empowering and Renewables Cybress Creek Renewables. That project has been waitlisted and twice withdrawn.

On April 18 the county passed Wild

on S. 216th Ave. near Kangley's curve off Route 53, just east of the city line. New Energy Equity intends to place solar panels on 18 acres at that location.

Presently under county review are Champion Solar LLC, a 32-acre project by Trajectory Energy Partners located on South Water Street (Route 102) at W. Ballou Road; and a 48-acre solar facility at Rivals Road and Route 102 by owners Mark and Kimberly Hansen with applicant RPIL Solar 13, LLC. The Rivals Road project went before the Will County Planning and Zoning Commission on Tuesday.

Dietz noted the city can comment on the projects with the county, but it has no authority in the approval process.

"Even the county has no ability to stop them," said Will County Board District 1 representative Katie Deane-Schlottman. "The way the state law is written they took away any control at the county and municipal levels. It's very frustrating to me that even at the county level we have no say.'

Deane-Schlottman explained how Illinois Public Law 102-1123 (HB4412) effective Jan. 27, 2023, defines the param-

Wilmington firefighters didn't have to go far to find out they had a big fire at 8:22 p.m. Tuesday, June 25.

They were at the station when smoke and flames could be seen above the tree tops coming from the west side of town. Right away the 9-1-1 call to 300 N. First St. was upgraded to a full commercial box cart alarm.

'There was no hesitation that a full alarm would be needed," commented Fire Chief Tim Zlomie. "A commercial box brings in a lot of resources to help fight a big fire like this. It's a good sized building and it was already pretty involved.

Nine departments, including Braidwood and Coal City, were dispatched to the scene while two others—Manteno and East Joliet—were on standby at the Wilmington station. When first responders arrived,



eters counties can review commercial solar proposals but as long as they meet the state's requirements, the county must approve them. Lawmakers in Dec. 7, 2023 increased the timeframe for counties to hold a public hearing from the date an applicant has filed from 45 to 60 days, but mandates a county has 30 days after all hearings to approve of the projects.

"The law was written by people who don't know jack about agricultural and the concerns of rural com-Deanemunities," Schlottman said. "There's 57 solar projects being proposed in Will County right now and a million questions about each one of them. Are these companies leasing or owning the property? Are they U.S. companies or foreign-owned? Will they be responsible for the maintenance or will that be hired out? What materials are being used? Noise levels? Fire safety...the list goes She feels those ques-

tions and more should be answered before counties have to meet the 60-day deadline required by law. "It's crazy what these

companies are offering the owners...\$30,000, \$40,000, even \$50,000 per acre to lease their land. I don't blame the landowners for saying yes because that's more than they can make from farming,' Deane-Schlottman said.

One solar facility in particular hits home for Deane-Schlottman. She said it will be outside the backyard Shorewood home. "Literally it's being planned on land adjacent to my subdivision. It's land that was proposed residential and now it's going to be a solar facility. I won't call them solar farms because they do not intend to farm a thing."

She shared her frustration of sitting through a 4-5 hour County Board meeting hearing public opposition to solar projects and then in the end it gets passed anyway. She knows of three permits the county denied and now all three of the applicants have filed lawsuits against the coun-

"I'm not against solar energy. I just want answers to the questions people like you are asking. Might it be better to have solar on a smaller scale and rooftops without taking away good farmland? How can it be done and they be good neighbors? We need better answers. Until then, I am a hard "no" on solar."

Deane-Schlo said the best thing to do is to submit opposition, or support, in writing to the County Board and Planning and Zoning. "Put your concerns in writing and send it so it becomes part of the application

process. The County Board will see that and take that

into consideration. She also encouraged residents to write state lawmakers urging them to revise the law, includes local reps Anthony DeLuca (195 W Joe Orr Rd Suite 201, Chicago Heights, IL 60411) and Senator Patrick Joyce (179 S. Wall St., Kankakee, IL 60901)

"Put the pressure on your reps to make changes and give us some local Deane-Schlottman said. "They keep coming and coming and we have no ability to stop them. That's disruptive to local planning and mapping out a future for many towns. That needs to change."

Mayor Dietz noted how the Wild Cat project is in the Wilmington Facility Planning area earmarked for future residential. "Now we have to block off that property for 20 years. There are concerns if there will be an impact on home values. Will potential developers have those concerns too and look elsewhere?

That was just one concern shared by residents, along with safety concerns like increased levels of heat for homes nearby, glare from solar panels, possible radiation and the condition of the land when eventual deconstruction of the solar facility is done. One neighbor across from the Wild Cat site asked if anyone studied the impact it will have on wildlife. A creek along the acreage is used by deer, turkey, waterfowl and other animals.

'Your concerns need to be part of the record during these hearings," Deane-Schlottman reminded residents. "We are making it as difficult as possible for these applicants and we will continue to fight them but we need opposition in writing. It always comes down to a vote and if you're opposed to having solar panels out your back door then tell county and state officials in writing. Your voices do matter but must be heard on paper or email."

Dietz said the city has shared its opposition with the county while knowing it has no control. While annexation would be ideal, increasing the city's tax base, that won't happen unless the landowners

want to annex. Carbon Hill getting a second chance

The Village of Carbon Hill met last night to reconsider an annexation agreement for a large-scale solar energy system on its north border.

The is the second time BAP Power Corp of Aliso Viejo, CA, doing business as Cenergy Power, an Illinois corporation, has approached the village to annex 42 acres owned by Scott and Keith Giordano. The village board

passing the agreement ear-

lier this year. But now that

it's apparent the solar facility will be approved by Grundy County under state mandate, the project is back with a offer sweetened for the small commu-Cenergy Power is offering the village an upfront contribution of \$400,000 in two installments. The solar utility would also offer Carbon Hill residents a minimum

30% utility bill credit, resulting in a reduction in electric expense for every homeowner. The credit would apply to costs associated with the transmission and distribution portion of their bill. In addition, the village would receive an annual contribution of \$35,000 on Aug. 1 of each year for the life of the 20-year project. That contribution would be adjusted by the village's portion of the Grundy County Real Estate Tax Bill for the solar facility. For

example if the total tax bill

were \$5,000 and \$1,000

was attributable to the vil-

lage, the contribution would be lowered by \$1,000 to \$34,000 for that Cenergy Power would still have to meet state regulations for natural screening around the property, pay all tap-on fees as a sewer and water user, and designate an easement for future water and sewer lines on the west end of the

property. The agreement requires a vote of twothirds of village trustees to

Robert Whitney Waterman, Governor

Waterman was born in 1826 in Fairfield, New York to a family of eight children. He was a hard worker from an early age. At the age of 13, in 1839, he moved to Newbury, Illinois to join a brother as a clerk. He eventually moved to Geneva where he clerked and was postmaster.

In 1850 he sold his assets, left his wife and child, and headed west to another brother prospecting for gold. The story goes that he befriended Brigham Young on the way. After one year of finding nothing, Waterman returned to his family in Illinois, who by then had settled in Wilmington.

He was a man of action as well, we read on April 27th, 1872, "Two fellows entered the grounds of R. W. Waterman, Esq., on Saturday night, and robbed him of all the peaches on one fine tree - not content with this, and giving their appetites whet up for fruit, they concluded to try grapes the next night, but R. W. was "around" with a gun full of mustard seed and coarse salt. He got sight of them at last, and blazed away. He says it was fun just to see those ducks "Get up and git," each with a hand on the rear of his breeches, and howling as though they were half killed. All this is very nice, but we cannot but censure Mr. Waterman for not having loaded his shooting iron with buck shot, and fired to bring down his game. There is nothing in this wide world

so mean as a fruit thief, and the man who brings one to grief should receive the thanks of the whole town.' In 1873 Waterman sold out his holdings in Illinois and once again tried his hand at getting rich in California. In 1880, while residing in San Bernardino, Waterman discovered a silver mine a few miles north of Barstow, California, then called Grapevine. In 1881, he formed a mining partnership with John Porter called Waterman and Porter, with 3/4 of the interest owned by Waterman. A stamp miĺl settlement about four miles away was named Waterman. The Southern Pacific Raliroad came through Waterman in 1882 and 100 men were employed at the mill and mine. The mine produced 40,000 tons of ore (\$1.7 million worth) before it closed in 1887 after silver prices declined.



Were no guns





Times have changed in the Illinois Senate

the last couple weeks of the spring state legislative session, Senate President Don Harmon got whacked twice allies, including Gov. JB Pritzker, but still managed to keep his cool.

On May 14th, the pro-choice powerhouse group Personal PAC issued a blistering press release blasting the Senate super-majority for an "unacceptable decision" to strip abortion services from the governor's birth equity bill, which banned co-pays and other added insurance costs for most prenatal and postnatal Gov. Pritzker quickly

chimed in, saying if the House-approved bill was indeed stripped of abortion coverage, he wouldn't sign Eleven days later - the day before the Senate took

up the state budget package - an internal administration talking tration talking points memo was mistakenly sent as a blast text message by a member of Pritzker's staff to House Democrats. The incendiary blast text was sent shortly after the Senate Democrats, in consultation with the Republicans, amended a House bill reforming the Illinois Prisoner Review

Senate's bipartisan amendlivehearings, which the Pritzker administration claimed at the would time cost a fortune and, according to the mistak-

enly texted memo, was actually part of a plan to undermine the state's Supervised Mandatory Release (MSR) program because hearing officers would be intimidated into not releasing deserving prisoners while being video streamed. "This is a right-wing

wolf in disingenuous transparency clothing," the administration's text told HDems. "It eliminates MSR by design. And it's appalling that senate democrats [sic] are so eager to please their Republican friends that they would undermine justice and push to keep people incarcerated who, by measure of actual law, should be out

There was real fear in the building that the accidental broadside could derail the budget.

Through it all, though, Harmon didn't overreact. The entire budget package cleared his chamber with far more Democratic support than it received days later in the House. Things

"It did not trouble me ment included in a way it may have in the requirements past," Harmon told me last week after I asked if he had streaming PRB matured over the years.

The Senate, he pointed out, eventually "passed the birth equity bill, and in the form it was passed." He later added, "I think there were some misunderstandings that could've been resolved by a telephone call." And Harmon said of

intending to pick fights. It was a bit of a surprise to me the level of engagement and the way it happened. I'd much rather work with the governor to make this work than to spin our wheels for nothing." He said he'd be "happy" to have a conversation with the governor to "make sure all voices are heard" going forward.

"In the end, we're judged by what we produce, not the rough drafts in between," Harmon said. "The partnership with the governor, responsible budgeting has been a real anchor here for all of us I think. And again, my priorities going into any session are to do the best I can to make sure the members of our caucus have the opportunity to advance legislation that's important to them, and to make sure we adopt a responsible, balanced budget. So, I try to focus on those things and not worry about the politiseems to be part of our process.'

Harmon and the governor didn't start off on the best terms. The two were old allies, but their top staffs just did not mesh well, to say the least. But, Harmon told me that things started to change toward the end of the 2023 spring session.

"Ĭ think the challenges we faced in passing the budget last year have solidthe relationship the PRB amendment between the Senate staff imbroglio: "We weren't and the governor's staff and the governor's staff and demonstrated our ability to work well together," he told me.

Harmon wouldn't specify what those "challenges" were, but it's pretty obvious what he meant.

Last year, House Speaker Chris Welch agreed to a budget deal with the other two leaders. An announcement was made, but then Welch got heat from his caucus and needed to find more money for his members. Rather than walk away, Harmon and Pritzker and their staffs worked with Welch to find a solution.

Former House Speaker Michael Madigan wouldn't have been nearly as accommodating, to say the least. Making accommodations and overlooking attacks just weren't his thing. Times have indeed changed.

Slight rise in gas due to holiday

prices in Illinois have risen 2.1 cents per gallon in the week. averaging \$3.82/g Monday, according to GasBuddy's survey of 4,378 stations in Illinois. Prices in Illinois are 8.3

cents per gallon lower than a month ago and stand 6.4 cents per gallon lower than a year ago. The national average price of diesel has risen 1.4 cents in the last week and stands at \$3.77/g. In the immediate area,

we're at the high end, with Braidwood running \$3.82/g across the board. Wilmington ranges from \$3.38/g at Mohsen to \$3.92/g in town. Coal City's gas was \$3.76/g at one Shell and \$3.79/g at the other

Further afield prices are lower. In Morris, expect to pay \$3.28/g at BP, all the way up to \$3.79/g at Amoco. In Bourbonnais, gas is \$3.29/g at Gulf and \$3.51/g at Speedway.

"As we approach July 4, motorists have seen the national average price of gasoline inch up ever so slightly for the third straight week," said Patrick De Haan, head of petroleum analysis at GasBuddy. "While the increases

have been fairly tame, with oil continuing to hold above \$80 per barrel, we could continue to see the national average climb slightly. For many Americans hitting the road for the July 4 holiday, prices in most areas are very com-

Ĵuly 4. However, with Hurricane Beryl formed in the Caribbean, we're reminded that gas prices could experience some jolts in the second half of the summer should a storm threaten refining capacity in Texas or Louisiana.

According GasBuddy price reports, the cheapest station in Illinois was priced at \$3.17/g while the most expensive was \$5.19/g, a difference of \$2.02/g.

Add remaining 5 cups water and stir well. Pour over ice and serve, or transfer to refrigerator and allow to chill several hours before serving.





The fight against wildlife trafficking

Dear EarthTalk: How is the fight to prevent wildlife trafficking going?

- L.K., Chicago, IL



Wildlife trafficking, defined as the illegal trapping and/or poaching of wildlife for consumer trade, is second only to habitat loss as one of the largest modern threats to wildlife. The criminal practice

overwhelmingly targets elephants, large reptiles and coral, and has resulted in the extinction of rare species of plants, reptiles and fish. High extinction risk is common among species targeted by wildlife crime; of the 4,000 species worldwide that are currently poached for trafficking, percent are already listed as threatened or nearthreatened.

people, as many foreign animals can spread dangerous diseases to previously unexposed people livestock. and Impoverished peoples in the poached animals' countries of origin are especially harmed by the industry, as the profiting criminal organizations often blackmail people with limited financial options into doing dangerous work for them.

Despite the wildlife trafficking has caused to wildlife and people, the industry has continued to expand over the last century, and now has an estimated annual value of roughly \$23 billion. Thanks to practices such as trophy hunting, hoarding and exotic tourism gaining momentum over the years, the demand for poached wildlife goods has only increased. Additional access to

the industry has been provided by the convenience, and anonymity of online transactions, making it harder than ever to track the trans-

portation and delivery of tal efforts to collaborate goods. Many nations that suffer from high rates of wildlife trafficking also lack sufficient law enforcement and security to adequately monitor their borders for many governments, nonprofits and environmental workers are making efforts to remedy these issues. In 2022, the United

Agency States for International Development committed \$75 million per year towards reducing trafficking in more than 35 African, Asian and Latin American countries. The money will go towards behavior change campaigns, more careers in conservation, increased law implementation and security capacity so that borders are more consistently monitored.

Similar efforts from the likes of the United Nations Office of Drugs and Crime and the non-profit Wildlife Conservation Society have already led to a 35 percent increase in convictions for wildlife crimes. These programs are key in our sociewith governments, indigenous peoples, local communities and local tourism and transportation to discourage wildlife crime.

Trafficking often feels illegal traders. However, like a distant issue, but there are still ways for us to combat wildlife crimes. For starters, any evidence of online trafficking should be reported to the Coalition to End Wildlife Trafficking Online or the National Wildlife Crime Unit.

Tourists should also exercise caution when encountering especially exotic goods, experiences or foods. You can verify if some organic products specifically fish, supermarket goods, and products made with palm oil — are sustainably sourced by visiting the websites for Good Fish Guide, the Giki app, and the Roundtable on Sustainable Palm respectively.




